

It must be ensured that all the details of the farmer are entered properly in a legible hand before the end of the Rabi Marketing Season 2016. A meeting of the Arhtiya Association should also be called by tomorrow and appropriate instructions may be given to them regarding filling up of this Registration Form. You have to also make arrangements for return/retrieval of this form fully filled up by all farmers who sold their crop through arhtiyas on or before 15<sup>th</sup> May, 2016.




