

Revised rent/charges of Rooms and other Facilities in Kisan Bhawan, Sector 14, Panchkula and other Rest/Guest Houses of Haryana State Agricultural Marketing Board in the State

The 206<sup>th</sup> meeting of the Board of Directors of Haryana State Agricultural Marketing Board, was held on 26<sup>th</sup> March, 2015 at 3.00 PM under the Chairmanship of the Additional Chief Secretary-cum-Chairman, HSAM Board, Panchkula in his office room. In this meeting, the agenda regarding revision of rent/charges of rooms & other facilities in Kisan Bhawan, Sector-14, Panchkula and other Rest/Guest Houses of HSAM Board in the state was considered and approved. As per the approved agenda the new rates/charges are as given in the tables below. These new rates/charges will be applicable from 1<sup>st</sup> of May 2015 onwards.

Revised Charges for Rooms in KISAN BHAWAN, Panchkula (In Rupees) :

Dormitory Bed	Rs. 200/- for each bed in dormitory and common room.

Note:-

1. No change/revision in the rates fixed for farmers.
2. For extra bed/mattress to be provided in rooms, additional charges shall be Rs. 150 for each extra bed/mattress.
3. If key of any room is lost by the guests/occupants, Rs 500 shall be charged extra from the guests for purchasing of new lock and key ring.
4. Advance booking of rooms will be confirmed only after 100% advance payment at the time of booking.
5. Advance booking can be cancelled any time by the HSAM Board without giving any reason or notice.
6. Advance booking amount of dormitory and common rooms shall not be refunded on cancellation.
7. Above rates shall be applicable only on the bookings and payments done after the implementation of these rates, any advance payments made before the implementation of these rates shall be charged as per the old rates.
8. Any Taxes or Levy applicable on the date booked shall be charged extra.
9. In case a person cancels the advance booking of rooms before 7 days of the date of booking, advance payment shall be refunded after deducting 20 % amount of the advance payment otherwise advance shall be refunded as under
  - i. 5 days before the date of booking : 40% of advance shall be deducted.
  - ii. 3 days before the date of booking : 80% of advance shall be deducted.
  - iii. 2 days before the date of booking : 100% of advance shall be deducted.

1. For the HSAM Board employees family member's functions in blood relation (Father, Mother, Sister, Brother, Son, Daughter) 30 % discount shall be given on the above rates for Basement Hall, Multipurpose Hall and Lawn only.
2. Above rates shall be applicable only on the bookings and payments done after the implementation of these rates, any advance payments made before the implementation of these rates shall be charged as per the old rates.
3. Any Taxes or Levy applicable on the date booked shall be charged extra.
4. In case a person cancels the advance booking of Basement Hall, Multipurpose Hall and Lawn before 30 days of the date of booking, advance payment shall be refunded after deducting 20 % amount of the advance payment otherwise advance shall be refunded as under
  - i. 20 days before the date booked : 30% of advance shall be deducted.
  - ii. 10 days before the date booked : 40% of advance shall be deducted.
  - iii. 5 days before the date booked : 50% of advance shall be deducted.

- vi. 5 days before the date booked : 50% of advance shall be deducted.



1. Advance booking of rooms will be confirmed only after 100% advance payment at the time of booking.
2. Advance booking can be cancelled any time by the HSAM Board without giving any reason or notice.
3. Above rates shall be applicable only on the bookings and payments done after the implementation of these rates, any advance payments made before the implementation of these rates shall be charged as per the old rates.
4. Any Taxes or Levy applicable on the date booked shall be charged extra.

5. If key of any room is lost by the guests/occupants, Rs 500 shall be charged extra from the guests for purchasing of new lock and key ring.
6. The concerned market committee shall maintain the day to day accounts of the rooms booked at Rest/Guest house of their respective market committee and maintain the records of the bookings and shall also retain the duplicate copy of the payment receipts issued to the visitors/guests (having name, address and designation of the person stayed).
7. In case a person cancels the advance booking of rooms 2 days before the date of booking, advance payment shall be refunded after deducting 20 % amount of the advance payment and no refund shall be made if cancellation is done thereafter.
