Subject: - Regarding Digitization of Vouchers.


Please refer to the Finance Departments instruction No. 28/22/2017-5B&C dated 19.09.2017 on the subject cited above, vide which the State Government had decided to make Digitization of Vouchers mandatory in the entire State of Haryana, in two phases:-

1. All DDOs of District Treasury offices w.e.f. 02/11/2017.
2. All DDOs of Sub-Treasury offices w.e.f. 01/12/2017.

However, the implementation was show due to non-procurement of e-tokens/dongles by the Departments. It has now been decided to make Digitization of Vouchers mandatory (for all Departments in the State) w.e.f. 01-02-2018.

You are requested to procure e-tokens / dongles well before 01-02-2018 and use them, failing which the e-billing system will not allow to generate bills.

These instructions may kindly be brought to the notice of all concerned in your Department for strict compliance. These instructions can also be downloaded from the Finance Department website www.finhry.gov.in.
