The scheme was circulated to you vide letter referred to above. The Coupons to be issued to the farmers are being sent to you through your D.M.E.O. The purchase season for this draw from 1.9.2015 to 15.12.2015 is further extended upto 31.01.2016. You are, therefore, accordingly directed to issue coupons to the farmers on production of "J" form issued by the commission agents for non MSP crops purchases/ Private purchase of agriculture produce in each notified mandis of your market committees for the purchase season commenced from 1.09.2015 upto 31.01.2016.

You are also directed to put a stamp on the coupons regarding the period of the crop seasons for this draw i.e 1.9.2015 to 31.01.2016 and the date of draw 18.02.2016 on the prescribed space in the coupons to be issued to the farmers from your market committees. You are also directed to get prepared two transparent Fibre Glass boxes for putting the coupons of Market Committee level draw and State level draw and ensure that the counter files of each & every coupons issued to the farmers should be put in the concerned box duly sealed to be kept in your market committee office. Further you are directed to maintain the record of counter files in a separate register with the name of Farmer, Adhaar Card No. & his full address of the Farmer. It should also be ensured that the coupons are issued to the farmers on non MSP crops which are not purchase by Govt. agencies and as per norms & conditions mentioned in the scheme already circulated vide memo referred to above. You should also ensure that wide publicity through your staff, commission agents, wall paintings etc. made for intimating to farmers to collect their coupons & tentative date of draw for this Krishak Uphar Yojana.

You are also directed to follow all directions & conditions mentioned in this scheme sent to you earlier.


